This is in continuation to our earlier communication dated 23rd April, 2025, regarding the Show Cause Notice issued under Section 8 of the Telangana Profession Tax Act, 1987 and the Rules framed thereunder, in relation to the non-payment of Profession Tax and non-filing of tax returns.

In this regard, we wish to inform you that the Company duly responded to the said Show Cause Notice issued by the Government of Telangana Commercial/State Taxes Department. In our response, it was clarified and substantiated that the requisite Professional Tax had been duly paid.

Subsequently, on 10th October, 2025, the Company received communication confirming the closure of the said Show Cause Notice and nil demand by concerned professional tax office, endorsed on 9th October, 2025. With the receipt of such communication, this matter stands closed.
